

# OFFENSE INFORMATION FOR BRANSON MUNICIPAL COURT

You have been given a summons to appear in the Circuit Court of Taney County, Missouri, Municipal Division of Branson. Your court date is listed on your ticket or on your bond form.

**FOR GOOD REASON** you may have the hearing date changed, but you **MUST** request this change **BEFORE** your court appearance date. This request may be made to the Clerk by telephone at 417-335-4578. Please wait 7 days after you receive your ticket before contacting the court.

If you do not want to appear in court, you may satisfy those offenses listed on the back by:

1. Signing the back of your ticket; and
2. Mailing the ticket with a Cashier's Check or Money Order for correct amount payable to:

If you fail to appear on the date designated, or on the date to which your case is continued, a WARRANT will be issued for your arrest and a suspension may be placed on your driver's license. Maximum penalty on all charges in the Branson Municipal Court is \$500 fine and/or 90 days in jail.
