

**AN ORDINANCE AMENDING THE BRANSON MUNICIPAL CODE, SECTION 62-11 TO INCREASE CERTAIN PARK USER FEES.**

**WHEREAS**, the Board of Aldermen of the City of Branson desires to provide recreational and cultural programs to the area, and

**WHEREAS**, the City of Branson has had an increase in the costs of providing these programs, and

**WHEREAS**, it is the recommendation of the Branson Park Board to amend these user fees, and

**WHEREAS**, the increased cost of providing these services to the general public has made it necessary to increase these fees, and

**WHEREAS**, it is now appropriate for the City of Branson, Missouri to amend the recreational user fees in an effort to recoup a portion of the monies expended on the programs.

**NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRANSON, AS FOLLOWS:**

**Section 1:** That Section 62-11 of the Branson Municipal Code is hereby amended so that Section 62-11(a) & (d) shall hereafter read as follows:

(a) *Park program user fees.* Park program user fees shall be as follows:

(1) *City-organizaed park program fees.* If a family has more than one child participating then the fee will be[ ~~\$20.00~~ ] **\$25.00** for the first child and [~~\$15.00~~ ] **\$20.00** for each additional child. The Park Director is authorized to establish and award hardship scholarships for persons who meet the criteria of the program.

(d) *RV park user fees.* [~~The following user fees shall be paid by users of the Branson Lakeside RV Park effective immediately, upon passage of this section:~~]

Discount Fee—Any camper staying for seven consecutive days will be eligible for a weekly rate of \$129.50 (seven days at \$18.50)

Monthly Site Fee	\$ 542.50

Discount Fee—Any camper paying the first month rate of \$542.50 (31 day stay at \$17.50) will be eligible for second month rate and each continuing month of \$472.50.

Wagon Master (Rally Coordinator):

Any camper who is the coordinator (Wagon Master) of a Rally which occupies eleven (11) or more campsites, shall receive one (1) such campsite free without charge, during scheduled Rally dates. (Campsite to be located in same vicinity as Rally.)

Additional People \$2.00/day over age 18
